**WHO :** Area Youth **8 - 12 years old**  
**(Limited to 200 youths-first 200 entries received)**  
**(Must be accompanied by a responsible adult - no more than 5 youths per adult)**

**EQUIPMENT:** Equipment will be provided (up to 150) and **will be given only to those who did not participate in a previous derby and do not already have their own equipment.** We will be verifying participation in previous Derby's.

We will stop taking applications once we reach either 200 total applications or 150 applications stating they need equipment, therefore **the applications must be hand delivered** (no mailing).

**For those who are eligible to receive the free equipment, it will be theirs to keep after the Derby!**

**COST :** None!!!

**PRIZES:** Derby Trophies will be awarded by age category.  
In addition, there will be door prize drawings for the participating youth.

**HOW TO REGISTER:** Registration/Waiver form is on the **back side of this flyer** which is being distributed to City of Muskegon, Orchard View and Reeths Puffer Schools and North Muskegon Elementary. **The registration/waiver form must be signed by a parent or legal adult guardian.** (If there is any youth who has not received a form at school and wishes to participate, their parent/adult guardian can go to the Muskegon or Muskegon Township Police Department). **The forms must be hand delivered to the Muskegon Police Department or the Muskegon Township Police Department as we will be operating on a first come first served basis. Once we have reached the maximum number of entries we will not accept any more applications.**

**No forms will be accepted after June 7th.**
