- 3. RR permit is not in hand yet. It was submitted in March and is expected soon.
 - a. Insurance requirements of the RR permit will be required by the contractor.
- 4. SESC: A Soil Erosion and Sedimentation Control permit HAS been issued for this project.
- 5. Engineering estimate: \$162,727.00
- 6. City Hall building will be closed. Due to Covid, City Hall is closed to the public. Bids will be accepted at the Police Department, entrance located off of Jefferson Street.
- 7. Crushed concrete near water: Crushed concrete cannot be used near a water way. The SP stating this was inadvertently left out. Add the attached SP "Crushed Concrete Near Water" to the contract.
- 8. Culvert and end sections: The culvert and end sections listed on plan sheet 2 were inadvertently left off of the bidding quantity sheet. Add these two items and use the attached bidding quantity sheet.
- 9. Silt boom: Silt boom is not required at this time. This may be a requirement of our EGLE permit, at which time a price will be negotiated before installation.
- 10. Clearing: Any clearing of vegetation necessary to complete the job is incidental. No additional payments or pay items will be awarded for clearing.
